## AMBULANCE PERSONNEL should:

- A. In addition to Standard Precautions initiate DROPLET PRECAUTIONS before entering.
- B. DISTRIBUTE and COLLECT Passenger Locator Cards for (i) Passengers seated within two metres in each direction from the ill person (ii) persons who reported DIRECT CONTACT with patient, (iii) crew serving the person or that section.

**ATTENDING PATIENT ON AIRCRAFT:** 

- C. FORWARD these priority cards with report copy directly to local PUBLIC HEALTH Medical Officer of Health (MOH)
- D. REQUEST CABIN CREW to: (i) Broadcast the Travel Health Alert Announcement (ii) Distribute and collect Passenger Locator Card from ALL OTHER passengers and crew (iii) Distribute a copy of the Travel Health Alert Announcement leaflet to all passenger and crew (iv) SEND completed Passenger Locator Cards to local Public Health MOH
- E. ALL WELL PASSENGERS should then be allowed to DISEMBARK, using the nearest exit.

\*Exposure within 2 metres of a confirmed or probable case of plague

\*Aircraft/ship exposure within 2 metres of a probable or confirmed case of plague in the **last 7 days**. A risk assessment to identify contacts (including passengers or crew) of the case should be carried out. \*Contact with the following items without appropriate personal protective equipment (PPE):

- infected substances of human origin (SoHO),
- laboratory exposure to plague infected materials,

- contaminated materials

\*Contact with a sick animal/flea bite in a plague affected area
